Susan R-H will f/u with Barbre to make sure she is able/willing to continue as SoBay rep Still would like to Board reps for Religious Education and Social Justice

Criteria for Posting on SUUN Website

(Drafted by RevD 2/27/15; added to SUUN website "Events Listing" by Ame on 2/23/15)

Must be related to an activity, event or information that is for all the congregations in the San Diego Cluster including:

SUUN facilitated or sponsored events such as concerts or conferences.

Social Justice activities endorsed by the SUUN Board as a Cluster-wide event

Events or activities such as theater productions or concerts in individual congregations that are cleared on the SUUN Calendar in order to support each other in our endeavors.

Special events not sponsored or facilitated by SUUN but identified as being of importance for the other cluster congregations by the SUUN Board.

Not support on the SUUN Calendar

Classes, Forums, Lectures activities and other events that are focused on the members of one specific congregation and take place in the course of normal congregational life.

Cluster BBQ - Taste of UU 2015

Tentative date August 22, 2015 at UUFSD – Board reps to check with their congregations to confirm this date works ... communicate yes/no to Board group preferably by 4/30/15, so Ame can get this listed on website.

Agreed to f/u on planning at May 2015 meeting, including whether offer event free, charge, or by donation only.

Budget Issues

Review contribution (by congregation) total = \$3,800/yearReport latest budget (through 1/31/15; received 2/21/15) = \$2,798Susan R-H will f/u to find out if we can get more timely budget reports – now only sent every two months on/about 21^{st} of month ... so next report not expected until 4/21/15 (with data through 3/31/15).

One issue is will we have adequate funds to offer BBQ free (except charge for liquor)?

2014 BBQ total expenses = \$2,884 (including food, musicians, staff)

Consider EventBrite registration – charge fee or contribution only
